

## Announcement

Dean of the Faculty of Pedagogy and Psychology  
of the University of Silesia in Katowice  
announces an open competition  
for the position of a university assistant lecturer  
in the Institute of Pedagogy

The competition is open to persons with an impeccable ethical attitude, meeting the conditions set out in art. 113 para. 1 of the Higher Education Act of 20 July 2018 (Dziennik Ustaw /Journal of Laws/ of 2018 item 1668, as amended) and the following entry requirements.

Entry requirements:

1. Impeccable ethical attitude.
2. Holding the academic degree of doctor of humanities / social sciences in the discipline of pedagogy
3. Academic achievements in the field of general pedagogy, history of education
4. Experience in qualitative research methodology
5. Taking an active part in scientific life, manifested in presentation at all-Polish and international scientific conferences and symposia
6. Teaching experience, especially in general pedagogy, history of education
7. Positive opinion of the immediate superior on the qualifications and aptitude for scientific and teaching work, if the candidate is an employee of the university.

Information: the teaching duties will be performed in Polish.

The candidates should submit the following documents:

1. Application for employment / entry to the competition.
2. CV together with information about the previous employment history.
3. Personal questionnaire for the candidates for work,
4. Copies of diplomas: master's and doctoral degree (with the originals available for inspection),

5. List of publications,
6. information about participation in scientific conferences and symposia, information about scientific activities, participation in research projects, information about organizational activities for the University
7. information about teaching activities,
8. Copies of other documents confirming the possession of required qualifications,
9. Declaration complying with Art. 113 par. 3 and 4 of the Higher Education Act of 20 July 2018
10. Candidate's declaration that the University of Silesia in Katowice will be the primary place of work.

Information:

Candidates will be interviewed on 12.03.2019 at the seat of the Faculty at ul. Grażyńskiego 53 in Katowice, room 101. The interviews will start at 10:45

The interview will mainly focus on professional development, interests and the parametric achievements of the candidate.

The results will be known within 2 months of the date of the announcement of the competition.

The candidate selected in the competition procedure will be employed by the rector, at the application of the dean of the faculty, after consulting the faculty council. The employment will be made under an employment contract after 19.03.2019

The first employment at the University of Silesia will be for a definite period of time.
